Arrest a number of Kurdish students and activists across Syria

Arrest activist Dr. Ferzand Omar

The air-forces Intelligence service detained the activist Dr. Ferzand Omar at Damascus airport while He was coming from Aleppo city at 4 pm on Sunday 18th March 2012.

Dr. Omar is internal Medicine doctor, lives in Afrin city, was born in Aleppo in 1970. An activist in the committees of the Kurdish Spring in Syria and the current construction of the Syrian state, and he is known as a supporter of civil peace

Kidnapping the activist Abdul Rahman Sheikh Haidar

A militia of Shabiha kidnapped the activist Abdul Rahman Sheikh Haidar bin Mohammed on Friday 15th March from inside the Great Mosque (Zakaria Mosque) in Aleppo. And Sheikh Haidar was born in 1977, from the village of Jollaqaan in Jendderais area in Afrin region, and a second year student at the Faculty of Law at Aleppo University, an activist in the protest movement in Syria.

Arrest the citizen Jwan Abdul Rahman in Qameshli

The citizen Jwan Abdul Rahman was arrested on the morning of 25th June 2012 in Qameshli city with two of his brothers and his father. The father and two brothers were released a few hours later after tortured them and broke the father`s finger. But Jwan is still detained such as dozens of thousands of young people in Syria since the start of protest movement a year ago across the country.

Arrest of the student Jekirkhuin Abdul Razak Mulla Ahmad

The military security branch in Aleppo arrested the activist Jikerkhuin Abdul Razak Mulla Ahmad on 3rd March 2012, a fourth year student at the Faculty of Mechanical Engineering at Aleppo University.

Arrest the student Peyman Khalil Mostafa

The student Peyman Khalil Mostafa was arrested for the third time on 26th March 2012 from his workplace in Rukeddien-Damascus by the security forces. He was born in Qameshli in 1988, a graduated of the business college in Damascus and studies accounting.

Arrest the student Lawned Semmo

The citizen Lawned Semmo (a student at Aleppo UNI) was arrested on the eve of Newroz , the Kurdish national festival, on 20th March 2012.

Arrests in Wadi Almeshri`e (Zorava) in Damascus

A Military Security Branch patrol and a supporting militia who known as shabiha raided the homes in Wadi Almeshri`e (Zorava) in the capital, Damascus on Monday, 5th March 2012 , and arrested of a few people from different ages, including a woman and a 64-year oldman. During the arrest campaign the detainees were beaten and insulted.

Detainees who were known are:

Shebal Temer yacoob and the brothers: Jwan, Samir, Jekirkhuin, Shoreshe, and kaled and their father Abo Samir, and another man known as Abo Daleel with two of his sons.

Kurdish conscripts were killed for refusing to shoot the protesters

The conscript Suleiman Saleh Mulla Hamza, from kerbikili village in Terba Seppi area in Hasaka province, was shot after he refused to shoot the demonstrators and tried to leave the army in Al-sanamin area in Dara`a province, where he was performing his military service in one of the units that stationed there.

He had telephoned his family and expressed his fear of killing the soldiers who refuse to fire on the demonstrators before he was assassinated a few days later. The family received his body from the hospital of Qameshli on 14th March 2012.

The family of the conscript Issa Hussein Issa received her son body in Qameshli city in the evening of 14th March 2012, who had been assassinated for refusing to fire on demonstrators in Damascus.

As well as the Kurdish conscript Walid Mezkeen Mahmoud were killed on the 31st March 2012 in Homs. He was born in the village of Shitka in Treba Seppi area in Hasaka province.

Release the teenager Goran Ali

The teenager detainee Goran Ali son of mohammed Tawfeeq has been released from prison on 25th March 2012 after a month in the detain.
